Information About Measure G for Davis Joint Unified School District



Highly Qualified Educators Teach in Davis Schools

Here in the Davis Joint Unified School District (DJUSD), we believe great teachers are at the center of student achievement. While DJUSD is committed to attracting and retaining high-performing teachers, state funding for DJUSD schools is nearly \$1500 less per pupil than the state average, resulting in lower staff compensation than in neighboring districts. To ensure that our students are taught by the best teachers available, DJUSD has identified options for protecting high-quality instruction in Davis schools.

Local Funding to Maintain High-Quality Education

With 26% of teachers and 37% of support staff expected to retire in the next 3 to 7 years, the DJUSD Board of Education voted unanimously to place Measure G, a \$198 parcel tax measure, on the March 3, 2020 ballot. This measure would provide \$3 million per year to keep great teachers and staff in Davis schools and attract the best and brightest to Davis in the future.

Local Funding to Attract and Retain Teachers

If approved by 66.67% of voters, Measure G funding would be dedicated to supporting teachers and school staff and would:



Attract and retain high-performing teachers and educational staff



Provide quality educators to support strong academic programs in reading, writing, social studies, math, arts and sciences







Maintain high-quality teaching for continued educational excellence in local public schools



Ensure students have the teaching support needed to prepare them for college and 21st-century careers

Fiscal Safeguards Are Included

-  All revenue from Measure G would be spent here in our Davis schools
-  No funding could be taken away by the State
-  A citizens' oversight committee and annual financial reviews would help ensure all funds are spent as promised
-  No funds would go to senior-level district administrators' salaries or benefits

"To attract and retain quality teachers and staff by keeping compensation competitive in order to (a) preserve outstanding instruction in math, science, reading, writing, history, social studies and technology; (b) support arts, music; (c) limit class sizes; and (d) support student health and safety; shall a Davis Joint Unified School District ongoing parcel tax of \$198/year, adjusted annually for inflation, be adopted, raising approximately \$3,000,000/year, with senior, disability, employee exemptions and citizens oversight; for District schools only?"
